Meeting Minutes 9/23/13

Vice President of Student Affairs Dr. Gitau- Presentation on Department Restructuring

The Department of Student Affairs is conscious of changes demanded by the student body and is working to address those issues effectively by constantly reviewing policies, focusing on accountability of staff and results generated by students. Student engagement and diversity services are top priorities for the department.

A few highlights from Dr. Giatu's presentation:

- NKU staff is working to develop a culture of inclusive excellence by advancing collaboration and relationships within the department including:
 African-American Programs and Services (new title), Latino Programs and Services (new title), and the addition of LGBTQ Programs and Services (new program). A Women's Services division is being considered and would largely address domestic violence.
- The department has also added **Fraternity and Sorority Life**, directed by Kim Vance, to address the growing Greek community.
- Dr. Gitau wants to ensure that more **testing facilities** are offered on NKU's campus **to cater to and retain students**, such in the case of standardized education exams.

- Health, Counseling, and Student Wellness is to be expanded to address substance abuse, sexuality, and nutrition.
- Student Success is to be geared towards assessment of programs, staff, and student results by utilizing the **University Connect and Persist** division to meet the needs of struggling students.
