I. Call to order

President Sami Dada called to order the regular meeting of the NKU Student Government Association at 3:32 p.m. on April 24th, 2017 in Governance Room (SU 104).

IV. Reading of Minutes

A. President Sami Dada did not bring up minutes to be read or voted upon. They will be brought up in the first meeting of next semester.

President Sami Dada entertained a motion to move New Business to the top of the agenda. Senator Hannah Edelen sub-moves the motion and Senator Tyler Andre seconds. Vote taken, passes unanimously.

V. New Business

- A. President Sami Dada announced his recommendations for the appointed positions
 - Chief Justice Justice Haley Madden
 - Experienced with the new SOCOP Program
 - Discussed her vision for the upcoming year
 - Wants the Judicial Council to be more involved

The floor was opened for discussion for 5 minutes. General discussion was held for 5 minutes. A call to question was made by Senator Hannah Edelen and seconded by Senator Jachelle Sologuren. It was approved unanimously. The vote was taken and the results of the Senate vote were 10 for the approval and 1 dissenting with 8 abstentions. The Senate voted to approve Justice Haley Madden to be confirmed by the Judicial Council. The Judicial Council confirmation vote was then brought to the floor. The vote was held and the results of the vote were 1 vote to approve and 2 votes to reject. The Judicial Council rejected the confirmation of Justice Haley Madden as their Chief Justice.

President Sami Dada stated that the appointment will be readdressed in the Fall Semester.

The floor was opened for discussion for 5 minutes. General discussion was held for 5 minutes. Discussion on the floor was extended for 3 minutes by a motion from Senator Adam Zarnowski and seconded by Senator Hannah Edelen. A call to question was made by Senator Hannah Edelen and seconded by Senator Miriam Davis. It was approved unanimously. The vote was taken and the results of the Senate vote were 2 for the approval and 7 dissenting with 9 abstentions. The Senate vote rejected the proposed appointment of Irakoze Dieudone.

It was approved unanimously. The vote was taken and the results of the Senate vote were unanimous for the approval with no abstentions. The Senate vote approved the proposed appointment of Senator Evan Berkemeyer.

Discussion on the floor was again extended for 2 minutes by a motion from Senator Janiah Miller and seconded by Senator Adam Zarnowski. A call to question was made by Senator Zach Stone and seconded by Senator Janiah Miller. It was approved by a vote of 6 yeas to 3 nays, with 6 abstentions. The vote was taken and the results of the Senate vote were 9 for the approval and 2 dissenting with 5 abstentions. The Senate vote approved the proposed appointment of Senator Jachelle Sologuren.

- Academic Affairs Senator Janiah Miller
 - Discussed her dedication through involvement and attendance at SGA even though she lost in the Freshman Election
 - Was appointed in the Spring for one of the openings
 - Discussed the Foundation of Knowledge Resolution
 - Wants more Diversity

The floor was opened for discussion for 5 minutes. General discussion was held for 5 minutes. Discussion on the floor was extended for 3 minutes by a motion from Senator Zach Stone and seconded by Senator Adam Zarnowski. Discussion on the floor was again extended for 5 minutes by a motion from Senator Jachelle Sologuren and seconded by Senator Adam Zarnowski. Discussion on the floor was extended for the third for 2 minutes by a motion from Senator Onyi Okorie and seconded by Senator Miriam Davis. Discussion on the floor was again extended for the fourth time for 1 minute by a motion from Senator Adam Zarnowski and seconded by Senator Edelen. A call to question was made by Senator Zach Stone and seconded by Senator Adam Zarnowski. It was approved by a vote of 10 yeas to 0 nays, with 5 abstentions. The vote was taken and the results of the Senate vote were 7 for the approval and 8 dissenting with 3 abstentions. The Senate vote rejected the proposed appointment of Senator Janiah Miller.
