- The week-long event officially became Black History Month in 1976 when President Gerald Ford extended the recognition to "honor the too-often neglected accomplishments of Black Americans in every area of endeavor throughout our history."
- It is said that February was selected by Woodson because it
 was the birthday month of two great Americans who were
 instrumental in shaping black history Abraham Lincoln
 (February 12) and Fredrick Douglass (February 14) as well as
 build upon the tradition already in place of celebrating those
 birthdays and extend on the study of Black history.


