- Director of the Center for Global Engagement and International Affairs
- Vice President for Enrollment and Degree Management (by invitation)

### **Membership Appointment:**

Members serve by virtue of their position (ex officio). The Provost may change the A-Deans Council membership as needed.

### **Membership Terms:**

Because members serve by virtue of their position, they serve while they hold the designated position.

**Frequency of Meetings:** Monthly

**Expected Lifespan:** Ongoing

**Reporting Requirements:** No reporting required.

### **Operating Procedures:**

The A-Deans Council Chair sets the agenda and schedules the meetings. Agenda topics are agreed by consent.
