But here is my blurb anyway for anyone curious.

As a professor in the School of Computing and Analytics (SCA), I have played a senior role within my school (and previously the Department of Computer Science), the College of Informatics (COI) and the University as a whole. I have been a member of the UCC since 2002 and chair, member of the Faculty Senate executive committee and senator since 2011. As chair of the UCC, not only do I set the agendas and preside over our meetings but serve as an ex-officio member of the other curriculum-related committees (General Education Committee, Graduate Council and the college curriculum committees – excluding Chase) and act as a resource for faculty, program directors, chairs and deans to advise on curricular matters, answer questions on the curriculum process and assist with the UCC forms (via the Curriculog portal). I also assist with researching previous curricular changes by searching our archives of electronic curricular forms. Outside of my role on the UCC and senate, I regularly chair our program's RPT committee, serve on promotion committees, mentor junior faculty, SCA's policy committee, volunteer for several recruiting events every year (e.g., doing hands on AI-related activities with visiting high school students, Norse Days), chair the college's curriculum committee and serve on the COI program workgroup.

## **Candidate Statements for 2026-2027 Faculty Senate Budget Committee Chair**

My name is Nathan De Lee and I am a professor of astronomy and physics in the department of Physics, Geology, and Engineering Technology. I have been a faculty member at NKU since 2014, and I have served as my department representative on the budget committee off and on since the Fall of 2016. In this role, I have seen many state budgets come and go, been involved with faculty surveys, and pushed for answers to hard questions as NKU has faced a number of budget challenges.

To be most useful to the faculty senate and the university as a whole, I believe the faculty senate budget committee should develop and provide a series of consistent metrics and plots to understand and evaluate NKU's fiscal health at any given point in the year. This would make it easier for new faculty joining the committee to become engaged, and it would make it easier for the committee to see long term changes as well as the needs of the moment. As a result, I have recently begun leading a subcommittee of the budget committee to develop those metrics and plots. Beyond the overall fiscal health of the university, I would continue to push on our perennial questions of salaries, capital expenditures, etc.
