FACULTY SENATE MEETING

November 15, 2010

The meeting was opened by Faculty Senate President Alar Lipping at 3:05 pm. The minutes of the September 20, 2010 meeting were approved.

Guest Reports:

- **University President** (Jim Votruba):
 - Revenues from the state have stabilized and are slightly up, but deficits remain.
 No further reductions are being discussed at this time.
 - o NKU is working on budget restructuring (NOTE: The university has a budget of \$200M, with \$140M of that discretionary). This restructuring is focusing on: a) reducing administrative infrastructure (\$2M already saved looking at the possibility of another \$2M-\$2.5M); b) Streamlining of Academic Affairs, c) reviewing revenues (including tuition, fees, alternative sources and student credit hour/FTE); consulting firm hired to review several areas (report due in February) including the "student experience", financial aid/business services, post-ERP (SAP) implementation, procurement and organizational structure.
 - o NOTE: A 1% salary increase for all campus personnel equals \$1M

• **Provost** (Gail Wells):

- After Griffin Hall opens, there will be the opportunities to renovate some of the classrooms and replace aging furniture
- o Discussion ensued regarding class size and the full-time to adjunct teaching ratio
- The College of Business Dean search is continuing with candidates on campus over the next few weeks
- o The College of Informatics Dean search is continuing with candidates coming on campus early in the spring semester

- o A Northern Kentucky University Chase College of Law arbitration team won the American Bar Association Regional Arbitration Competition
- A team of Northern Kentucky University computer science majors placed first at the 2010 Regional Association for Computing Machinery (ACM) Programming Contest
- Reappointment/Promotion/Tenure binders are being reviewed in the Provost's office

• Faculty Regent (Chuck Hawkins):

- Board of Regents met on November 10 and discussed: a) NKU financial report; b)
 the faculty/staff recruitment process; c) creation of the Center for Public History;
 d) Talent Development and Gifted Studies program; and e) personnel issues
- **CIO** (Tim Ferguson): Tim Ferguson gave a presentation regarding IT activities at NKU. Some of the highlights included:
 - Now that SAP implementation has been completed, there will now be a shift of focus in IT to the academic side (vs. the business side) of operations. OIT is working this Gartner on a strategic plan
 - Governance for OIT includes: ITAC (Information Technology Advisory Committee), MyNKU Advisory Workgroup, IT Policy Council, and a Student Advisory Group
 - OIT will be seriously considering a leasing plan in 2011 as part of the annual computer replacement plan. Implementation of leasing should bring the university closer to a 4-year computer replacement cycle
 - o Griffin hall will be going online in 2011
 - Network improvements as well as wireless access improvements have been made across campus
 - o Improvements have been and are being made for mobile technology access
 - Several initiatives are underway to improve computing access for NKU faculty/staff/students
 - o Reviewing the increase of funding for academic initiatives
 - In the process of creating a team to focus on instructional technology exploration/adoption and design
 - o Smart classroom improvements will be forthcoming
 - o Investigating the feasibility of providing laptops to all faculty who need them
 - Ongoing SAP upgrades taking place in particular the upgrade of the process for students filling out online evaluations
 - Ken Rhee mentioned that anyone interested in serving on the ITAC should contact him

Committee Reports:

- **Curriculum** (Richard Fox):
 - A subcommittee has been formed to look at the new General Education Committee's role and also other recommendations
 - o Five General Education courses will come up for a vote at the December meeting

- The Search Committee for the Director of General Education should have candidates finalized in January
- **Benefits** (Alar Lipping for KC Russell): Summer Fellowships, Grants and Sabbaticals recommendations have been forwarded to the Provost
- Constitution Revision (Steve Weiss): An interim General Education Committee will be formed to review policy issues which need to be addressed. This committee will consist of a minimum of 8 members. At least half of the membership will be from Arts & Sciences with the other half from areas outside of A&S. Pat Moynahan (Vice Provost) and Vicki Stieha, Interim Director of General Education will serve as ex-officio members.
- **Teaching Effectiveness and Enhancement** (Ken Rhee): The committee is working on the following:
 - o Online student evaluations. A sample statement for faculty syllabi was distributed
 - Reviewing the ability for faculty to customize the evaluation form (pilot testing in the spring)
 - o Faculty development workshops will take place in the spring

Officer Reports:

- **Senate President** (Alar Lipping):
 - The next Faculty Senate meeting will be on Dec. 13 at 3:00 pm (refreshments provided starting at 2:45pm)
 - Faculty Senate election voting deadline has been extended to 4:30 pm Nov. 19.
 Nominations being solicited for 2011/12 officers
 - o The Faculty Senate meeting of January 24, 2011 will be preceded by a meeting of the 2011/12 Senate and election of officers
- **Senate Vice President** (Carol Bredemeyer): Recently attended an AAUP Workshop on Governance. Details about the conference can be found on their website, in the Chronicle of Higher Education and on Inside Higher Ed.
