The minor in Pre-Law provides a coherent grouping of courses in the foundations and applications of the law. The program is designed to acquaint students with different approaches to the study of law, elements of legal reasoning, case law in substantive areas, as well as the skills necessary to succeed in a law school program.

Political Science Majors may count any two of the following courses: PSC 110 (required for major), PSC 304, or PSC 305 in that major and also in the Pre-Law Minor, but no additional courses may be double-counted therein.

Criminal Justice Majors may count JUS 210 and JUS 203 (required for major) in that major and also in the Pre-Law Minor, but no additional courses may be double-counted therein.
