- II. Call to Order 1:16pm
- III. Approval of March 10, 2016 minutes:
  - A. Request for amendment to attendance from Tiffany Budd, who was present.
  - B. Motion to accept the minutes as written with amendment to attendance made by Jeff Chesnut, and seconded by Chris Bowling; motion passed by voice vote.
- IV. Guest: Andy Meeks, Director of Business Operations & Auxiliary Services, joined us to answer questions about the areas under his supervision: ALLCard Services, the NKU campus bookstore, dining services, mail distribution and printing services, parking services, and BB&T Arena
  - A. Will parking prices increase next year? No, parking pass prices will remain the same for 2016-2017; other prices may increase. Over this summer, approximately \$400,000 will be spent to restore several surface lots on campus, and over the next few summers, an additional capital project will renovate the lots from behind the Kenton Drive Garage all the way to Norse Commons.
  - B. What restaurants will be in the SU next year? A Steak 'n Shake will take the place of Coyote Jack's; the transition will begin over Thanksgiving Break 2016, and the space will be walled off while work is done, with a tentative opening scheduled for the beginning of the spring 2017 semester. The menu will be close to the full menu, including milkshakes and hot breakfast items. Andy will send the menu when it's finalized, and pricing will be similar to a normal restaurant location. It will also be included in the mail plan options.
  - C. Is Outtakes going to be open this summer? Andy will find out and let us know for certain.
  - D. Catering policy: Andy talked about the reasons behind catering policy and costs, including setup, teardown, and liability. Generally, Chartwells is good about working with departments where non-perishable goods are concerned. He also talked about the various models of university/food service contracts: 1) resident board rates are priced higher to subsidize the remaining campus catering; 2) university commission on retail sales is reduced; or 3) neither (which is NKU's model), leaving prices at market rate. Andy also offered to return with a presentation on planning a budget-friendly catering event, and encouraged departments to have a specific budget in mind when contacting catering staff to help set parameters.
  - E. Dave pointed out a significant difference in pricing between the same size bag of chips from Outtakes (\$2.64) vs. an off-campus convenience store (\$0.99). Andy will check into



this further, including the request to increase the Diet vs. regular Mountain Dew ratio in vending machines.

- F. On-campus pouring rights: Andy reminded us that pouring rights (essentially Coke vs. Pepsi) will be out for bid later this summer, and there was a survey sent to the campus community to assess preferences.
- G. When parking rates do increase, is there a concept of how much? Not yet at this time.
- H. Have different tiers of pricing been considered for parking passes? Yes, and the Callahan rate was one example, but it was not popular.
- I. When the limited spots in Lot C return, what will the designations be? This has not yet been determined it could be a mix of handicapped, visitor, etc.
- J. Are electric charging stations being considered in any place on campus? Yes, they have been discussed, and at this point it is a matter of time to do the work figuring out how much it will take to install the electricity.
- K. Has an across the board fee for all employees been considered, since everyone uses sidewalks, and TANK is subsidized, etc.? That idea has not been considered thus far, but Andy will take it to the transportation committee.
- L. Could a tiered/bulk discount be considered in catering e.g., bottle of water \$1.50, gallon \$1.49; many bottles \$1.25? Andy will follow up on this with Chartwells.
- M. Was there a known issue with the new garage scanner gate during the heavy rain this week? Yes, but it was not yet clear if it was caused by the moisture, or simply an issue with the technology.
- N. Has Biz Bites been successful? Sales have not been great, so Andy will be talking with Chartwells and Dean Porterfield to determine the future of the outlet.

  - 1. Budget update
    - a) Legislature resolved a budget last night
    - b) Budget reduction of 4.5% (\$2.2 million) for NKU
    - c) Recurring equity funding of \$5.3 million in the second year of the biennium (2017-18) for NKU; WKU also received some equity funding
    - d) Overall, this means we will have a net increase in funding at the end of the biennium, which will not be the case for any of the other schools.

- B. Lori Southwood
  - 1. Online FERPA training will be available soon, with an email launch to come
  - 2. Payroll training, due date, and reporting updates
    - 1. Online training available for time admins (HR 200 through Blackboard)
      - 2. Payroll emails will now send an email with an automatic reminder for 9am on the day approvals are due at noon.
      - 3. Quarterly VP reports will be sent to divisional vice presidents detailing failures to approve time by the deadlines so potential areas needing assistance can be identified.
    - 3. Carole asked about alternative work schedules in facilities management which seem to require employees to take vacation time if they want to be paid for a full holiday (e.g., if someone works a standard 40-hr week on four 10-hr days, and a holiday falls on one of their work days, they would receive 8 hrs of holiday pay (1/5 of the work week), and use 2 hrs of vacation to supplement). One suggestion included offering an alternative option to allow those 2 hours to be worked a different day or days if possible. Lori will explore this with Facilities to learn more about the details.

## Wellness Committee Meeting Minutes

## **Discussion:**

- Monday Mile and As You Are Classes are continuing through the week of May 2.
- CPR/AED classes will be held next week in UC 135; April 20, 1-3pm; April 21, 9-11am; You can register on the Wellness website.
- 2016 Health Assessment
  - Kim is aware of the issues with the new scheduling system and portal, and is working with Healthworks to resolve the issues and make it easier for everyone involved next year.
  - o 2016 Annual Health Assessment Aggregate Data
    - 336 participants, 20% participation of eligible population, down from 428 last year
    - 42.5% age 50-64, 21.4% age 40-49, 28.9% 39 and below
    - BMI:
      - 43% normal; 16% borderline; 13% overweight; 28% obese
      - 6.9% lower than national average for obese Ntnl:34.9%
      - Overweight/obese=higher risk of developing high BP, type II diabetes, sleep apnea and cardiovascular disease
    - Waist circumference:
      - 60% low risk; 38% high risk
      - high = greater risk for developing Type II diabetes, high cholesterol, high triglycerides, high blood pressure and cardiovascular disease
    - Blood Pressure:
      - 44% low risk; 27% borderline; 8% high risk
      - NKU 21.1% better than the national average for high BP. Ntnl: 29.1%
      - High=greater risk for heart attack and stroke
    - Cholesterol:
      - LDL: 75% healthy; 20% borderline high; 5% high/high risk
      - HDL: 89% healthy; 11% low/high risk
      - Triglycerides: 85% healthy; 9% borderline high; 6% high/high risk
      - High LDL/Triglycerides and low HDL= high risk for heart attack, stroke and cardiovascular disease
    - Glucose:
      - 89% normal
      - 11% pre-diabetic (reversible with lifestyle changes)
      - Only 1 high risk
      - 12 self-reporting diabetics
