# **Business Operations and Auxiliary Services:**

- The RFP process for food and beverage services is underway. Proposals were received on December 21<sup>st</sup> and the selection committee will begin meeting upon our return for the spring semester.

#### **Human Resources**:

- W2's:
  - When electronic W2's are ready, time admins will be notified and it will be posted in ThisWeek.

#### IT:

- A new web dashboard and mobile app initially focused on students is now available. The dashboard and mobile app are personalized and mobile ready for all devices. A formal communication to students is scheduled for the week of January 14th. The new app can be found in the Apple and Google app stores.
- A VPN upgrade is scheduled the week of January 7th; expect to be asked to update the VPN client on your next log in to VPN.
- This affects Web Content Editors only The NKU CMS Adobe Experience Manager (AEM) is being upgraded; it starts Wednesday morning, January 9th, and should be completed by Sunday January 13<sup>th</sup>. The web editor (edit.nku.edu) will not be available during this time; however, the nku.edu website will not experience any downtime.

## **Staff Congress Questions and Comments**

- What is the name of the new web dashboard and mobile app?
  - Northern Kentucky University Mobile
- Ray Mirizzi from Operations and Maintenance passed away. Information is forthcoming
- KRS Rumors: Adam Caswell's Round Table pension presentation remains current
  - Examples of planning scenarios:
    - All new hires would not go in KRS or state pension, but would go in a defined plan
    - All existing employees would have a window of opportunity to decide if they want to stay in KRS or opt out; if they opt out, any benefit would remain and the employee would maintain that benefit upon retirement. This gives all employees a choice, but would not unduly harm employees.

- If employees do opt out of KRS in this planning scenario, will there be a resource to explain choices?
  - o Again, please remember that all discussion is in the planning stage
    - Hoping for a tool to allow employees to run numbers comparable to an online calculator with multiple outcomes
    - Group sessions, comparable to open enrollment
    - Will an external company offer one-on-one sessions? (A note from the Roundtable) This is still a possibility, but it may not be universal to all NKU employees
- To reiterate: the President will be transparent about all updates and will communicate promptly with NKU
  - Suggestion: What if there is a monthly update stating that there are no status changes? This could alleviate campus worries
- What happened to the December 17 proposal from KRS?
  - They did not release a proposal
  - They did express a need for a freeze
- What if employees wish to go outside of NKU for retirement options?
  - o This is not a current option
  - All options still require contribution
- Could employees go lower than 5%?
  - This is not a current option
  - o Currently at 6%, so 5% would be a lower option
