# **Board of Regents – Staff Regent Cori Henderson**

Cori Henderson shared a reminder that the BOR meeting is Wednesday, September 14 at 9 am. The morning session will include presentations by CDO, Darryl Peal on DEI initiatives at NKU and by Provost Matt Cecil on optimizing enrollment.

#### Administrative Liaison – Lori Southwood

Lori Southwood shared the following report:

#### Josie/Compensation:



- HR is monitoring the development in the area of employment law affecting exempt and non-exempt classification of employees. This Fall, the U.S. Department of Labor (DOL) is expected to announce changes to salary threshold for non-exempt status. Right now, staff with an annual salary below \$35,568 are automatically non-exempt, eligible for overtime pay.
- We don't know what the new threshold will be. A modest salary increase to the threshold is believed to be in the range of \$48,000 to \$50,000 annual salary. Even this modest increase will substantially impact our staff. We have started reviewing employees' salaries and classifications to stay ahead. (Faculty, and positions with duties related to imparting instruction, such as Coaches are always exempt under the law regardless of the salary threshold).
- We are following this issue closely, and will share additional information based on the developments from the Department of Labor.

# Chandra/Budget Updates:

- Producing the first set of Monthly Operating and Position Budget to Actual reports, of the fiscal year by the end of August, to assess July's performance and ensure staying within the overall authorized budget & by division. Working to achieve the targeted salary savings by division.
- Facilitating a monthly working session/collaboration between Academic Affairs, Budget, Enrollment, and the Comptroller's Office to refine the enrollment to projection process. Will be conducting Business Officer Meetings quarterly which will entail a training component, updates, informal discussions, and community building aspects with the individuals in the various divisions that most closely work with the budgets.
- Keeping performance funding metrics at the forefront as part of conducting budget to actual analysis and planning ahead for FY24.
- Funding from the state has been set aside internally for the asset preservation projects and that work is moving forward strategically.
- One-time institutional investments and Net Position Investment FY22 is now closed, the external auditors are providing their assessment of FY22, and then it will be determined exactly how to move forward with the identified institutional investments.

# Marquita/Training and Development:

- Coming Soon! In collaboration with IT and University Wellness, Training and Development has been approved for a Learning and Performance Management System. This will create a central repository for employee learning and new opportunities for building a talent pipeline for today and tomorrow, which includes: a formal onboarding structure, career pathing, and a succession planning process. This is also means automating and improving the staff performance evaluation process. The anticipated go-live date is in January/February 2023.
