Board of Regents – Staff Regent Cori Henderson

Cori Henderson shared the following report:

- BOR Meeting yesterday, June 12
 - Passed proposed budget
 - Reoccurring budget will have a small surplus, but non-reoccurring budget has a \$4.8 M deficit due to financial aid scholarships
 - Discussed concerns with increase to mandatory commuter meal plan.
 Faculty Regent, Spataro motioned to amend this fee by capping for two years. Motion did not pass.
 - There will be no raises this upcoming fiscal year. President and cabinet looking for opportunities for staff, such as removing the CRC fee for FY26.

Staff Congress Updates

Department of Labor's FLSA rule raising the exemption salary threshold, effective July 1, 2024. All of them have been notified about their transition from exempt to non-exempt status beginning the bi-weekly pay period starting on June 23, 2024. They have received helpful information regarding time entry requirements, overtime policies, vacation accrual, benefit deductions, and training sessions focused on these changes. On May 23, a coalition of 13 local and national associations, along with Texas businesses, filed a lawsuit in federal court in Texas challenging the U.S. Department of Labor's new rule setting minimum salary thresholds for exemptions under the FLSA. We do not yet know how or when the court will rule on this matter. In 2016, the court stopped a similar rule to increase the salary threshold just days before it was set to take effect, and it permanently blocked the rule in a 2017 order. It's important to remember that the effective dates for compliance have not been changed or blocked at this time. Thus, NKU, like most employers, is preparing to comply with the July effective date, as extensive planning, budgeting, communication, and system modifications are involved ahead of a change of this nature. However, NKU will continue to monitor developments from the courts and the DOL's Wage and Hour Division.

FLSA: A total of 48 staff members who are currently exempt are impacted by the

Floor Care


The Floor Care team is very small, but they worked hard to make our floor look shiny and clean. They do a good job even with the challenges they face.
