General Education Policy:

In the April 26 meeting, GENAAT approved the following policy. GENAAT Policy (recommendation):

II. F. Honors sections of approved Foundation of Knowledge courses do not need UCC approval. Although our student information system (SAP) identifies such sections as separate courses, the program views them as a “type” of the approved course.

After discussion with Alar Lipping, I decided that it would be best for the UCC to formally approve of the policy and then send it on to Faculty Senate. Both Kent Johnson and Mary Lepper have suggested a change, so I have an alternate proposal, provided below. We will discuss both proposals and hopefully vote to approve one of them on the September 15 meeting.

Proposed revision:

Honors sections of approved courses are considered to be separate sections of the course; they are viewed as a different "type" of the approved course. If the honors section is of an approved Foundation of Knowledge course, UCC approval is required so that the SLOs can be evaluated and compared to required SLOs.

The idea behind the revision is that we want to make sure that honors sections do not add to the *count* of general education courses, but that we still have adequate oversight to ensure an honors section does not stray too far from the original course to no longer be included in the general education program.

We will look to vote on this our next meeting.
