6. Old Business - None
7. New Business - Carole Beere has asked for permission to delete the courses that have not been taught in at least 5 years. This list has already been approved by department chairs. Usually the UCC does not vote to approve course deletions, instead they approved at the college curriculum committees. However, to meet the upcoming catalog deadline, Carole has asked us to approve the deletions rather than the CCCs. The following proposal was Approved:
 1. A list of courses that have not been taught in at least 5 years is generated via an SAP report
 2. The list of courses is sent to each department (e.g., computer information technology courses are sent to computer science) for chair approval
 3. Chairs are able to request that courses be kept active
 4. All remaining courses (those to be deleted) are sent to all department chairs for approval (in this way, we can ensure that a course required by another department is not deleted without that department's knowledge)
 5. All remaining courses after steps 3 and 4 are sent to the UCC for approval
