COAS CC submitted a unanimously endorsed proposal regarding handling cross college curricular items (that is, items that impact departments outside of the college housing the department proposing the curriculum change). Discussion ensued in which a consensus arose that rather than this be a memorandum of support, it be a memorandum of awareness. Joe Nolan was asked to modify the proposal based on feedback from the UCC. The UCC will continue discussion of this with a potential vote at the next meeting.
