4. New business – could a shift from 16 to 15 weeks negatively impact your programs?

Ask departmental colleagues for questions and concerns about changing structure of semester schedule.

Think about how courses might be impacted, faculty workload, process concerns, etc.

There was some preliminary discussion among UCC members about this proposed item. Some of the conversation related to scheduling, time between classes, rigor, start and end times for classes, start and end times for each semester, etc. Some members expressed concern about whether this would be a “forced change” the administration undertakes where faculty input is either not requested or not considered seriously, citing other implementations, such as the creation of online programs, partnering with AP, and lowering admissions standards for programs and departments. Some members expressed concern about the lack of faculty representation on the committee. And, some members expressed concerns about making additional significant changes that are not data driven or evidence-based.
