1. Minutes from 11/3/22 (email vote)
2. Chair Report:
December meeting will likely be handled with an email unless no items come up in which case it will be canceled. Reminder: deadline for Fall 2023 Catalog is the last March UCC meeting.

4. Old Business: The Focus and related issues.

Recall that some articulation agreements with area community colleges allow the associates degree to count for the secondary area of study (in lieu of a minor or focus). Should this be allowed? Questions arose as to which programs have these, how frequently this occurs, and whether the associates degrees in question have content that is offered at NKU.

Discussion ensued whereby faculty expressed some concern for this practice but given how busy we all are, the thought was to postpone any further discussion until after the catalog deadline, if at all.

Current definition of a focus:

A focus consisting of at least 12 semester hours in courses numbered 300 or above, in a discipline that is different from the student's major.

Proposed new definition (by Fox):

A focus consisting of at least 12 credit hours of courses numbered 300 or above with the same designator; as many as 6 of the credit hours may have other designators as long as the courses are related and the department chair/school director or program director of the courses with the common designator approves the other courses.

This allows for multidisciplinary foci and exceptions. It also clarifies what "discipline" means from the original definition.

Allen Cole noted that by the time the new catalog is out, a new workflow for degree audit will be in place whereby the department/school responsible for the focus will have to approve it. This will permit a mechanism whereby courses outside of the focus designator can be used for a Focus. However, do we want to use a rule as explicit as the proposed rule? Fox and Kattus will work on

a revised definition for our next meeting. One other suggestion arose from Cole in that departments can more explicitly word their catalog copy to indicate that a multi-disciplinary focus is available.
