4. Old business: continued discussion of the Focus

New definition for the Focus:
"A focus consists of at least 12 credit hours of courses in the same designator that are numbered 300 or higher. A focus that contains courses with differing designators may be permissible if all courses are related to a single discipline/topic. Approval from the departments which house the courses is required in such cases. Students should seek approval in advance to ensure that the selected courses make up a legitimate multidisciplinary focus. Note: a multidisciplinary focus may also be available within some departments. See the department's catalog description for details of availability."

Terry Pence has offered a slight variation on the above definition (after having removed the reference to multidisciplinary to use interdisciplinary instead):
"A focus consists of at least 12 credit hours of courses in the same designator that are numbered 300 or higher. An interdisciplinary focus may also be available from interdisciplinary programs within some departments. See the department's catalog description for details of availability. A focus that contains courses with differing designators may also be permissible if all courses are related to a single discipline/topic. Approval from the departments which house the courses is required in such cases. Students should seek approval in advance to ensure that the selected courses make up a legitimate multidisciplinary focus."

There is also a question of whether a dept can control the minimum grade required for a course to count toward a focus. Suggested that the definition be further amended with "(see Department Catalogue for Grade Requirement)".

The following amended definition was submitted, seconded and approved.
"A focus consists of at least 12 credit hours of courses in the same designator that are numbered 300 or higher. An interdisciplinary focus may also be available from interdisciplinary programs within some departments. See the department/school's catalog description for details of availability. A focus that contains courses with differing designators may also be permissible if all courses are related to a single discipline/topic. In such a case, approval is required from the department/school that will house the focus. When a focus consists of courses with differing designators, students should seek approval in advance. Minimum grade restrictions may apply, see the department's entry in the catalog for more detail."

The definition will be submitted to Faculty Senate at the end of February for review.
Faculty also requested that Allen Cole share the interdisciplinary programs already encoded in the SAP database. Allen agreed to share the list with Richard Fox, so that the UCC can review, these will be available for UCC to examine and share with their respective departments and programs.
