- 1. Approval of the Minutes: No corrections.
- 2. Chair Report

  - d. Richard asked if anyone objected to COI continuing to have three representatives on UCC. There were no objections.
- 3. Curricular items
  - School of Allied Health CVP 622 non-voting term change
- 4. New business for the year
  - a. Issues involving credit hours students graduate with was discussed. This was old business from last year. UCC did not seem to wish to proceed with the investigation in our group but felt the research might better be accomplished with individuals who had greater access to student graduation numbers. Issues involving introducing more 300 level courses into General Education was also brought up. Kimberly Weir, who had worked on this last year did not wish to pursue it again this semester and in general continuing this discussion met with little interest to the committee.
  - b. Richard offered a revised definition for the Focus: "12 advanced hours separate from those of the student's major that either are of courses that share the same designator or are part of a major or minor in the catalog". Having grade restrictions was discussed. It was agreed to put this on the agenda for the next meeting for discussion and possible vote. It was noted that there are three Foci specifically listed in the catalog that need to be removed.
