SANTAS, SANTAS, SANTAS

During our Christmas Trivia Zoom meeting, one question dealt with Black Peter who is part of the Christmas tradition in the Netherlands. But did you know that there are other Santas as part of the U.S. tradition and that not all “Santas” look like our traditional jolly old elf.

Nast Santa: This is the way we picture Santa. This depiction is the creation of Thomas Nast who was a political cartoonist during the Civil War. This image first appeared on January 3, 1863 and was used as propaganda during the war. For more than thirty years, Nast drew various versions of Santa.

Coca Cola Santa: This version was created in 1931. It was drawn for the Coca Cola company’s Christmas advertisements. Until that time Coke had been thought of as a summer drink and the ads wanted people to see that it could be a good winter drink.

Russian: Ded Moroz (Old Man Frost or Grandfather Frost) brings presents on New Year’s Eve. He carries a staff and has a long white beard and wears a blue coat. He travels with his granddaughter who is called the Snow Maiden.

SENIOR TO DO LIST

It’s break time! While you’re free from classes, use some of this time to be sure you’ve done what needs to be done for college admission.

1. I’m sure you’ve checked email for your FAFSA Student Aid Report but in case you haven’t, please do that now.
2. Apply to NKU and any other college to which you intend to apply. If you’ve chosen a college and have been accepted, set up your email account at that school. Any information sent to you by that college will come to your student account.
3. Request a tax transcript if you haven’t done so. You’ll need one for your parents and you (if you filed) and you can’t use your tax form or the printout from a tax preparer. You can call and request this at 1-800-908-9946.
4. Check scholarship, housing, and any other deadlines. Also, check to see if applications for scholarships need to be submitted separately from your initial application.
